## Orgalime at the Financial Times Future of Manufacturing Summit

Automation, digitisation, servitisation... what exactly does the future hold for industry? At the Financial Times Future of Manufacturing Summit on 3 October, senior business leaders, policy makers and journalists assembled in London to find out.

Orgalime joined the debate as the representative of the European engineering sector – the largest industrial branch in the EU. Participating in a panel discussion, Director General Adrian Harris addressed the role policy should play in an industry landscape being transformed by digitisation. His advice to policymakers? The Fourth Industrial Revolution is underway, but it's still early days: regulating too much too soon could hinder innovation and prevent companies from unlocking the potential of data-driven business models.

## Spotlighting digitisation in Tallinn

European leaders to the Baltic state's capital for the Tallinn Digital Summit. On the agenda? The digital transformation of Europe's economy and society.

The [summit conclusions](#) covered many issues central to the digitisation of industry – from the free flow of data to digital skills, infrastructure and cybersecurity. Orgalime has weighed in on the debate in these areas, with position papers on the [data economy](#) and the importance of a [secure cyberspace](#) in the IoT arena.

Digitisation was again spotlighted in the Estonian capital on 19 September: 28 Member States plus Norway, the European Commission, and a number of industry associations including Orgalime signed the [Tallinn e-Energy Declaration](#) in support of accelerating the deployment of digital technology in the energy sector. Orgalime has long advocated digitisation as the basis of a modern, smart and flexible energy distribution system – as summarised in our [position paper](#) on the Commission's Clean Energy Package earlier this year.

Organised by the European Commission, Industrial Innovation Information Days on 3 and 4 October drew some 1,000 stakeholders to Brussels to discuss the future of industrial research in Europe.
